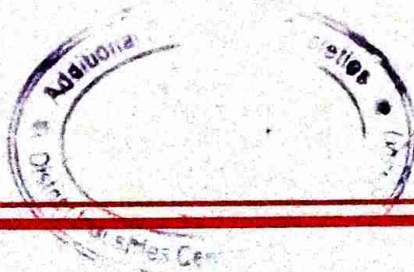

1. **NAME:** The name of the society/trust shall be Managing Committee RED RACHIS EDUCATIONAL SOCIETY, Nr. GOSAIN HOSPITAL, O/S BHANDARI GATE, BATALA DISTT GURDASPUR.
2. **REGISTERED OFFICE:** The registered office of the Managing Committee shall be RED RECHIS EDUCATIONAL SOCIETY, Nr. GOSAIN HOSPITAL, O/S BHANDARI GATE, BATALA DISTT GURDASPUR located in the premises of RED RECHIS EDUCATIONAL SOCIETY, Nr. GOSAIN HOSPITAL, O/S BHANDARI GATE, BATALA DISTT GURDASPUR in the state of Punjab.
3. **AIMS OBJECTIVE:** The aims object for which society is established are:
 - a) To undertake, promote, encourage and assist the study of all aspect of the education need and related problems of the young children in the age group of 3 to 25 years.
 - b) To lay down norms and standards for the educational program, we related to the different stages of child development.

 - p) All income of the society/trust shall be utilized solely towards the promotion of the aims of trust/society and no parts thereof shall be used by any of the member of the society for their benefit.

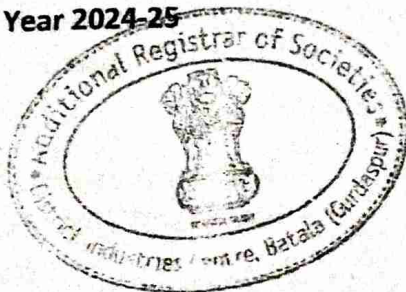

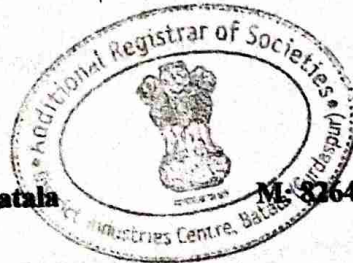
